Chair of the Huxley Summit Advisory Board

I warmly welcome you to the British Science Association's annual Huxley Summit. Now in its fourth year, the Summit provides a vital opportunity to gather business leaders, scientists, policy makers and opinion formers to discuss the scientific and social challenges of our times.

Our first Summit was held in November 2016, on the eve of the 'Trump election'. When we started programming this year's event, we did not plan for it to take place amidst a General Election campaign.

As a recovering politician, I find it fitting that our theme is 'collaboration in an uncertain world'. We must hope that the UK's protracted, still unresolved, divorce from the EU does not inflict lasting damage on our standing on the global stage, or our ability to represent a plurality of views and build consensus.

Beyond the fractured UK political landscape, 2019 draws to a close against a backdrop of trade wars and civil unrest in various corners of the globe – from Hong Kong to Catalonia and Lebanon.

In the face of the climate emergency, the world's second largest emitter of greenhouse gases is withdrawing from the Paris Agreement. While, from a global network to bring the world closer together, the internet is now threatened with fracture across country lines, with Russia and Pakistan most likely to

follow China's approach to regulatory power.

The question for us today is not whether collaboration is important (like motherhood and apple pie, most people agree that it is important), but what type of cooperation across organisations, sectors and nations is required to tackle complex, multi-disciplinary issues.

None of the major challenges facing global society – climate change, neuro-degenerative disease, energy security, technology regulation – can be tackled by one discipline, one section of society, or one nation alone. The UK – exemplified by all of us here at the Huxley Summit – must ensure that business, policy, science and the media continue to work together for the benefit of society.

Today we will seek to explore the role that science and innovation has to play in tackling some of these so-called 'wicked problems'. We will look at the issues of climate change and technology regulation, and how the UK can help drive progress against the UN Sustainable Development Goals.

In designing the Huxley Summit, we're aiming to deliberately blur boundaries; to encourage you to encounter people, ideas and viewpoints that differ from your usual day-to-day interactions. Thank you for attending. I hope that you find it a thought-provoking event.





**Gisela Abbam**Chair of the British Science Association
& Black British Business Person of the Year 2019

In today's political climate, it can often feel that we live in a divided world with no clear direction of travel. Communities have become disparate and siloed, dialogue is heated and unconstructive, and particularly for us at the moment, here in the UK, 'business as usual' has been put on hold because of the uncertainty we are living through. But the challenges of our time won't wait for politics to settle down.

Throughout the world, there are millions, if not billions, of people who don't have access to the most basic needs, including food, clean water and basic healthcare. And even those who do have access to these supplies are left to live on the fringes of extreme poverty. This is not acceptable.

I have dedicated my career to achieving better wellness outcomes for people across the globe through collaborative healthcare, in roles at GE Healthcare and Abt Associates. In 2016, my team and I successfully negotiated a policy with the World Trade Organization which eliminated tariffs on key medical devices, increasing access for patients in 80 countries.

I look at healthcare through a policy lens, cooperating with clinicians, governments and companies all around the world.

Collaboration is the driving force behind this, and only by working across not only different sectors, but also global boundaries, can we hope to solve these issues.

This isn't just true for healthcare in a global setting – in the past year, it has been impossible to ignore the huge resurgence of interest in, and urgency around, conservation and wildlife protection. A few weeks ago, Collins Dictionary revealed that their 2019 Word of the Year is "Climate Strike".

The devastating impacts of man-made climate change are happening now – remember the worldwide, record-breaking temperatures that brought countries to a stand-still just this summer, with places like France seeing unprecedented highs of 46°C.

Issues like these touch the lives of everyone on the planet and are as varied as the people we share our world with. On the surface, humankind's differences may seem like a roadblock for progress, with our multitude of ideas, cultures, and motivations making a Scottish farmer feel worlds away from a Bengalese factory worker, and an American business mogul seem like an alien creature compared to an Arctic Inuit.

But in the words of the late MP Jo Cox, "we are far more united and have far more in common with each other than things that divide us". Most of us want happy, healthy lives for ourselves, our loved ones and communities, while doing the best we can for the natural world and environment. But to achieve this, it's precisely the things that do make us different – our upbringings, gender, religion, age, etc. – that will bring the range of ideas, perspectives and differing voices that will solve some of society's greatest challenges.

We must join forces by encouraging cross-disciplinary collaboration, merging business ideas, and working with people from the other side of the political spectrum.

Homogenous thinking can lead to a stagnation in ideas. Fresh perspectives spark new and innovative interpretations, which create solutions that may never have been reached with the same people thinking about the same problems. Bringing people and institutions together from all walks of life will also allow us to become educated about different cultures and lived experiences, improving empathy, understanding and communication between individuals and nations. It would also allow for discrimination and "othering" to fade, as we start to see each other as a whole, rather than a divided planet.

We have a joint responsibility to work together and act on the challenges we all face, regardless of background or identity. We must draw on the individuals, communities and organisations who have the power and influence to make big changes, while listening to the voices that are so often drowned out, but are usually the most affected by health, climate, and technological problems.

We must join forces by encouraging cross-disciplinary collaboration, merging business ideas, and working with people from the other side of the political spectrum. By welcoming and enacting thoughts, action, and resources from people the world over, across all cultures and societies, we can all have a positive impact on the planet and the lives of its inhabitants.

There has been an increased focus on the role of business in wider society, including its role in meeting the Paris Agreement of limiting the increase in global average temperatures to well below 2C, as well as meeting the 17 UN Sustainable Development Goals.

The debate on shareholder primacy vs the role of business to deliver to all stakeholders (or put more bluntly - "profit vs purpose") is not new, but there have been major developments this year. The investor community's collective voice just keeps getting louder on the need for businesses to move away from short termism, towards a focus on delivering long term value for all stakeholders. The challenge however continues to be a lack of consistency or understanding of the metrics around the non-financial, intangible elements of business. A recent MIT study<sup>1</sup> highlighted a staggering lack of consistency among ratings agencies when evaluating corporate ratings based on ESG (Environmental, Social, Governance) metrics. Therefore, it has been hard for a company that invests in

innovation, strong governance, its culture, communities and sustainable practices relating to the planet to prove the long-term economic benefits to its shareholders. Also, businesses are responding to the wider public focus on a corporate's role in society. The US Business Roundtable – a group of CEOs of nearly 200 of (181 CEOs signed) the largest global businesses made a pledge to reject shareholder primacy and shift towards delivering benefits for all their stakeholders.

For many, the effects of climate change are becoming ever more obvious and the link between protecting our eco-systems and natural resources for continued human prosperity, inescapable. It seems like the world hasn't just woken up to the climate emergency, it has woken up screaming for change. When Mark Carney talks about the impact of climate change on corporates, "Companies that don't adapt will go bankrupt – without question." A big challenge lies ahead. But also an opportunity to build trust by showing how commerce can act sustainably.

At EY we are leading the way on articulating how businesses can measure and report on the wider impact to society and demonstrate the link to long term financial returns. Our work started last year with the Coalition for Inclusive Capitalism and over 30 leading companies with a combined value of more than US \$30 trillion. We continue to work with organisations such as the International Business Council of the World Economic Forum to refine and focus metrics, and work directly with businesses in key sectors such as Energy, Consumer Products and Financial Services to ensure they meet the needs of all stakeholders.

Recognising our own role in society, we have open-sourced our long-term value framework and made our research available to all, as well as beginning to measure our own wider impact on society. The partnership with the BSA's Huxley Summit provides a fantastic forum to share the imperatives but also the challenges. Together with the broad group of thinkers, policy makers and business leaders, we can work to deliver a better working world.

The New Voices have been selected in the following categories:

- · Science, tech and innovation
- · Policy and politics
- · Business and entrepreneurship
- · Media, community and campaigns

These young leaders, disruptors and change-makers have received international recognition for their work.
